

Agricultural and Marine Products Department



Imports fresh and frozen seafood and fresh vegetables from around the world and sell it to wholesalers, mass retailers, convenience stores, restaurants and other customers.

In the marine products business, we offer value-added products such as mackerel, salmon, tuna, and other raw materials landed in various parts of the world, which are processed at our partner factories in China and Vietnam. We have developed supply chains with overseas partners for fruits and vegetables to supply safe, secure, and fresh products.

Furthermore, we operate "JAL PLAZA" shops in 24 domestic airports and export high-quality Japanese sweets to Asia and the U.S., where they are sold through our locally operated stores and other select shops.




